ABSTRACT

This thesis aims to investigate the effect of the differences between English and Arabic in consonants and vowels on Sudanese undergraduates' pronunciation. The research intends to find out which of the English consonants and vowels that do not exist in Arabic are difficult for the students. For addressing these inquiries, the researcher hypothesized that the differences between English and Arabic in consonants and vowels cause pronunciation problems for the learners. An oral test and a structured questionnaire were used for collecting the required data to test the study hypotheses and obtain the objectives of the study. The subjects of the study were 50 third year students at Khartoum University, Faculty of Arts, English Department and 20 teachers of the field at the same university. The main findings revealed that the sound systems differences of English and Arabic affect students' pronunciation. This effect appears in students' mispronunciation of some English consonants and vowels which have no Arabic counterparts. Reached up to these results, more emphasis on those problematic consonants and vowels during learning pronunciation is required at universities. In addition, putting into account the sound systems differences between English and Arabic and developing the English syllabus accordingly.

مستخلص الدراسة

تهدف هذه الأطروحة الى تقصى تأثير الفروق بين اللغة الإنجليزية والعربية في الحروف الساكنة و المتحركة على نطق طلبة الجامعة السودانيين. للتوصل للاجوبة لهذه الاستفسارات, افترض الباحث أن الاختلافات بين اللغة الإنجليزية والعربية في الحروف الساكنة و المعتلة تسبب مشاكل في نطق اللغة الانجليزية لدى الطلبة. ولاختبار فرضيات الدراسة وتحقيق اهداف البحث, تم استخدام اختبار شفهي واستبيان منتظم لجمع البيانات المطلوبة. بلغ عدد المشاركين في الدراسة 50 طالبا في السنة الثالثة بكلية الأداب قسم اللغة الإنجليزية في جامعة الخرطوم، و 20 معلما في الجامعة ذاتها. كشفت النتائج الرئيسية للدراسة أن الاختلافات في الأنظمة الصوتية للغة الإنجليزية مما نتج عنه صعوبة لدى الدارسيين الإنجليزية والعربية تؤثر على نطق الطلبة للغة الانجليزية مما نتج عنه صعوبة لدى الدارسيين في نطق بعض الاصوات الصامتة والمعتلة التي لا يو جد لها نظير في اللغة العربية و واستنادا إلى هذه الأصوات التي تشكل صعوبة في نطقها خلال دراسة النظام الصوتي للغة الانجلزية في الجامعات كما انه يجب الوضع في الاعتبار اختلافات الانظمة الصوتية بين اللغة الإنجليزية والعربية وتطوير منهج اللغة الإنجليزية وفقا لذلك.
