ABSTRACT

Diabetic ulcers complications are a leading cause of hospitalization and amputation, with a15% life time risk in all diabetic patients. Many different methods have been proposed and their goal is to accelerate the wound healing. But these measures are often deficient to heal all diabetic ulces when the patient's own intrinsic wound healing system is insufficient. So more effective treatments are essential. The objective of this study is to asses the effectiveness of low level laser therapy in wound healing in chronic diabetic foot ulcer in addition of routine wound care. This is the first study done in Sudan , in Jaber Abu Aliz Diabetic Center in the period from 15February 2009 to 15May 2009.

Fourty three diabetic patients with chronic ulcer had been divided into two groups. Group 1 (23 patients) received low level laser therapy and nursing care, group II (20 patients) received only nursing care.

Initially the first group patient received low level laser therapy (diode laser) visible red wavelength(675) nm with energy density 4J/cm2 and cluster 46 diode laser with energy density 9.6J/cm2. Daily for one week, 3 consecutive sessions in the next week, then continue with 2 sessions per week in till the end of the study(3 months). The rate of healing in laser group is 57,4%, while in the control group is 29,5%. Six patients (26%) achieved 100% wound closure and 52% achieved more than 50% of healing during this period in group I, while in control group one patient

(5%) achieved 100%wound closure and 10% achieved more than 50% of healing during this period. Comparison between the laser and control group in rate of healing showed significant different between two groups by t-test, P Val is (0.004). We noticed dramatic response in pain relief in majority of patients in the laser group. There is a need to develop alternative treatment modalities which can improve the endogenous capacity of healing process, particulary during conditions with impaired wound healing. Using laser as a source of photobiostimulation is an attractive branch in medicine for the future. The study finding suggest that low level laser therapy is safe, accelerate wound healing, with the added potential resident of decreasing pain and increase sensation

ملخص الاطروحة

من مضاعفات قرح السكرى المكوث في المستشفى وبتر الاطراف ,مع حوالي 15%خطورة على حياة المريض .هناك الكثير من طرق العلاج التي تم استخدامها في علاج قرح السكرى التي كان لها الدور في الته هزة القرح,الا انها قد تكون غير مجدية في علاج بعيض قيرت السكرى المزمنة ونتيجة وجود خلل في نظام التام الجروح داخليا .لزا ايجاد طريقة فعالة لعلاج قرح السكري ضرورة .الهدف من هزة الدراسة تقيم اثار الليزر فرو القوة المنخفضة في علاج قرح السكري المزمنة باضافة الى العلاج التقتيدي.هؤة الدراسة هي اول دراسة في السودان,وقد اجريت في مركز جابر ابو العز في الفترة مابين 15من فبرايو حتى 15من مايو 2009 .

43 مريض مصاب بقرح السكري المزمنة قسموا إلى مجموعتين. مجموعة 1 (23 مريضا) تم علاجهم بالليزر ذو القوة المنخفضة واالعلاج التقليدي. المجموعة الثانية (20 مريضا) تتلق العلاج التقليدي فقط.

في المجموعة الأولى يتلقى المريض العلاج بالليزر و و القدرة المنخف ضه باستخدام الطيف الاحمر بموجة طولها (675) شدة طاقة قدرها 4 والاطياف المتعدد شدة طاقة قدرها 4 والاطياف المتعدد شدة طاقة قدرها 6 . 9 يوميا لمدة أسبوع واحد ،ثم يوم بعد يوم لمدة أسبوع اخر ثم تواصل الجلسات مرتين أسبوعيا. (6) من المرضى (26%) قد تم لهم الشفاء التام للقرح، (52%) تم الشفاء لديهم بنسبة أكثر من (50%) ، بينما تم الشفاء التأم للقرح في مجموعة الثانية بنسبة الالتمام بين الشفاء بنسبة الالتمام بين المجموعتين لوحظ فرق بين المجموعتين باستخدام اختبار ت (004 .0). خلال فترة الدراسة لوحضت استجابة هائلة في تخفيف الألم عند غالبية المرضى في المجموعة الأولى الذين كانوا يعانون من الألم المزمن هناك ضرورة لايجاد طريقة علاج فعالة لعلاج قرح السكرى المزمنة بعتبر علاج بديل وقد استخدام الليزر و و القوة المنحفضة في علاج قرح السكرى يسرع التام القرح التضح في هزة الدراسة أن العلاج بالليزر و و القوة المنخفضة لقرح السكرى يسرع التام القرح ويخفف الألم .
