#### Abstract

The research has the following as its specific objectives, to examine critically and trace the historical backgrounds of Islamic propagation in the selected areas in Kano State, to review the system of *Da'awah* being used in Kano State by some of the selected Islamic organizations, to try and identify the reason why some pagans after embarrassing Islam for some time, they later changed their faith to other religions, to critically analyze the role and contributions of some Islamic organizations towards the development of Islamic propagation in some areas of Kano State and to examine the problems being faced by some of the Islamic organization in conducting Islamic propagations in some selected areas of Kano State and offer some suggestions and recommendations with regards to its findings on how to improve the quality of Islamic propagation in the selected areas and Kano State in general. However, some of the findings of the work are, who ever intends to establish an Islamic organization should propagate Islam for the sake of Allah (SWT), exercise patience, confidence and determination in facing the challenges of *Da'awah*. In addition to above there is need to put more emphasis in involving and training more women on how to conduct Da'awah because some organizations have utilized their potentials and got positive results in many occasions. The research work has discovered that the pagans are still living in an uncivilized situation. They worshiped some creatures and performed magic. It was also discovered that some pagans were attracted by the incentives given to them by the Christian missionaries. Similarly, the research work has identified some problems that affect the implementation of the various *Da'awah* programmes by the organizations like lack of enough financial support, lack of long term Planning and lack of proper appraisal and assessment of Da'awah. Some of the recommendations given are, there is need to be arranging seminars to the preachers and an Islamic propagator should poses such qualities like wisdom and be able to implement the *Da'awah* programmes effectively.

إن كل من ينوي تأسيي منظمة إسلامية عليه القيام بالدعوة الإسلامية في سبيل الله ويلازم الصبر ويكون جديرا للثقة ويكون مصمماً لمواجهة التحديات الناجمة عن الدعوة.

وبالإضافة إلى المذكور أعلاه، هناك حاجة لمزيد من الاهتمام في مشاركة المرأة في الدعوة وتدريبها في كيفية القيام بها، لأن هنالك بعض المنظمات استفادت من مهاراتها وقدراتها على ذلك وكانت النتيجة إيجابية في مناسبات كثيرة.

وكشفت الدراسة أيضا أن الوثنيين ما زالوا يعيشون في أوضاع غير متحضرة ويعبدون بعض المخلوقات ويمارسون السحر. كما توصلت الدراسة إلى أن بعض الوثنيين يتم إغراءهم بالحوافز المقدمة عبر البعثات المسيحية.

توصلت الدراسة أيضا إلى بعض المشكلات التي تقف عائقاً أمام تنفيذ برامج الدعوة المختلفة التي تعدها المنظمات، على سبيل المثال: العجز في الدعم المالي الكافي والنقص في الخطة بعيد المدى وكذلك النقص في التقييم السليم للدعوة. من بعض توصيات البحث أن يكون هناك محاضرات والدروس عن كيفية الدعوة للدعاة ومن المستحسن أن يكون الداعي حكيم وقادر على تنفيذ خطة الدعوة بنجاح.
