ABSTRACT

This research, reviewed the role of UNDP in supporting human development in Sudan, through a case study applied to livelihoods project in the Office of UNDP - South Darfur state, focusing on the experience of beekeeping, livestock rearing, cultivation of peanuts and hibiscus, along with training programs for the IDPs.

Objectives of the research has been to highlight the situation of human development in Sudan through South Darfur state, definition of livelihoods project, the motives behind the implementation of the project in South Darfur state, definition of the project implementation phases, and the obstacles encountered during the implementation, identify the economic and social positive results and impacts resulting from the implementation of the project. the research follow the historical method, and descriptive analytical method (case study method) for data collection, classification, analysis and interpretation on account of test and dissemination of results.

The study clarify that through the experience of the UNDP, even in a conflict situation, development and livelihood activities can be carried out, livelihood projects have contributed to the improvement of some economic and social aspects, the trainings organized by UNDP, has helped IDPs to improve their situation and rely on themselves, lack of peace and security in South Darfur, is one of the biggest threats to development, the negative perspective towards the projects of foreign organizations limits the success of many of them, weak capacities of beneficiaries and lack of training is a challenge facing UNDP, in addition to poorness of infrastructure, the best projects for the state population are agricultural and industrial projects, as well as the quick impact projects.

The study attained the need for continuation of UNDP in implementation of development projects, even in a conflict time, implementation of more livelihoods projects in South Darfur, implementation of more IDPs trainings to build a self-reliant society, expanding coverage of livelihoods projects across the state, achieve and enhance security and sustainable peace, raise awareness of the beneficiaries towards the projects implemented by INGOs, strengthening infrastructure and paving the roads, increase development projects that target the main activities of the state's population such as agriculture and industry that rely on domestic production, build the capacity of NGOs, and cooperation of HAC to facilitate the work of the organizations and their movement within the state.

المستخلص

تناول هذا البحث، دور برنامج الأمم المتحدة الإنمائي في دعم التنمية الإنسانية بالسودان، وذلك من خلال دراسة حالة طبقت على مشروع تيسير سبل كسب العيش التابع لمكتب برنامج الأمم المتحدة الإنمائي بولاية جنوب دارفور، بالتركيز على تجربة تربية النحل، تربية الماشية، زراعة الفول السوداني والكركدي والبرامج التدريبية للنازحين.

وقد تمثلت أهداف البحث في: تسليط الضوء على حال التنمية الإنسانية بالسودان من خلال ولاية جنوب دارفور، التعريف بمشروع تيسير سبل كسب العيش، الدوافع من وراء تنفيذ المشروع بولاية جنوب دارفور، التعريف بمراحل تنفيذ المشروع والعقبات التي واجهت التنفيذ، التعرف على النتائج والآثار الاقتصادية والاجتماعية الإيجابية التي ترتبت على تنفيذ المشروع. اتبع هذا البحث المنهج التاريخي، والمنهج التحليلي الوصفي (منهج دراسة الحالة) لجمع البيانات، تصنيفها، تحليلها وتفسيرها لاختبار النتائج وتعميمها.

أوضحت الدراسة: أنه ومن خلال تجربة برنامج الأمم المتحدة الإنمائي، يمكن تنفيذ مشروعات التنمية حتى في فترة اندلاع الحروب والنزاعات، أن مشروعات تيسير سبل كسب العيش ساهمت في تحسين بعض الجوانب الاقتصادية والاجتماعية، كما أن التدريبات التي نظمها برنامج الأمم المتحدة الإنمائي، ساعدت النازحين على تحسين أوضاعهم والاعتماد على أنفسهم من خلال تحسين مكاسبهم، ولعدم تحقق الأمن والسلام المستدامين، لا زالت التنمية بجنوب دارفور متدنية، أن النظرة السالبة لمشروعات المنظمات الأجنبية تحد من نجاح العديد منها، أن ضعف قدرات المستفيدين وقلة التدريب تمثل تحدٍ يواجه برنامج الأمم المتحدة الإنمائي، بجانب ضعف البنية التحتية وصعوبة التحرك داخل الولاية، أن أفضل المشروعات هي المشروعات الزراعية والصناعية، بالإضافة إلى المشروعات سريعة العائد، وأن ضعف قدرات المنظمات غير الحكومية، إجراءات تسجيلها، وصعوبة الحصول على إذن التحرك تمثل بعض المخاطر التي تعيق تنفيذ المشروعات.

وقد خلصت الدراسة إلى: ضرورة استمرار برنامج الأمم المتحدة الإنمائي في تنفيذ مشروعات التنمية حتى في فترة النزاعات، تنفيذ المزيد من مشروعات تيسير سبل كسب العيش بجنوب دارفور، تنفيذ المزيد من تدريبات النازحين التي تساهم في بناء مجتمع الاعتماد على الذات، توسعة نطاق تغطية مشروعات تيسير سبل كسب العيش لتغطي المزيد من أنحاء الولاية، تحقيق وتعزيز الأمن والسلام المستدامين، رفع وعي المستفيدين تجاه المشروعات التي تنفذها المنظمات الأجنبية، تقوية البنية التحتية ورصف الطرق بالولاية، زيادة مشروعات التنمية التي تستهدف الأنشطة الرئيسية لسكان الولاية كالزراعة والصناعة التي تعتمد على الإنتاج المحلي، ويناء قدرات المنظمات غير الحكومية مع التأكد من تسجيلها من جانب، ومن جانب آخر مساهمة مفوضية العون الإنساني في تسهيل عمل المنظمات وحركتها داخل الولاية.
