5-1 Appendix A

## 5-2 Equations

If the factors of production are measured in efficiency units, and then the production function can be written in the form:

$$Y = F(\hat{K}, \hat{L}, t) \dots \text{append 1}$$

Where the respective levels of capital and labour sources are defined by:

$$\hat{K} = E_K(t) K_t \quad \text{and} \quad \hat{L} = E_L(t) L_t \quad \dots \dots \dots \text{append 2}$$

Thus,  $E_K(t)$  is a summary measure of the common factors affecting the efficiency of all units of capital irrespective of their times. By similar reason,  $E_L(t)$  is the summary measure of the common factors affecting the efficiency of all units of labour irrespective of their times.

Assuming that factors are paid prices equal to their respective marginal products and that the shares of the product to capital and labour,  $S_k$  and  $S_L$  respectively, exhaust the total product, total factor payments is defined as:

$$S_K = Y_K K \quad \text{and} \quad S_L = Y_L L \quad \dots \text{append 3}$$

That is  $S_k = PK$  and  $S_L = wL$  and the relative factor shares are defined to be:

$$S_k = \frac{S_K}{Y} = \frac{rK}{pY}, \quad S_L = \frac{S_L}{Y} = \frac{wL}{pY} \quad \dots \text{append 4}$$

It follows immediately that the relative factor share is equal to the elasticity of output with respect to that particular factor. Thus,

$$S_K = \frac{Y_K K}{Y} = \frac{\delta \ln Y}{\delta \ln K} = \sum Y_K, \text{ and } S_L = \frac{Y_L L}{Y} = \frac{\delta \ln Y}{\delta \ln L} = \sum Y_L - \dots \text{append 5}$$

With constant return to scale assumption,

$$S_K + S_L = \sum Y_K + \sum Y_L = 1 \quad \dots \text{append 6}$$
